Through the translated extracts we can see the beliefs and activities which had been formally condemned by ecclesiastical and secular authorities, but which had not yet become subject to widespread eradicating pogroms, start to be allied with heresy and with changing conceptions of demonic activity. The extensive introductory essay gives the reader the historical, theological, intellectual and social background and contexts of the translated documents. The translations themselves will all have introductory notes. This volume will contribute significantly to our understanding of the witchcraft phenomenon in the Middle Ages.
